**FACILITIES:** Sixteen lanes, seven feet wide, 25 yards long with non-turbulent lane ropes. Complete Colorado Timing System with 10 lane timing display; seating for 400 spectators. Minimum Depth is 4 feet measured from a distance of 1.0 meters to 5.0 meters from both end walls, and is as deep as 12 feet.

The competition course has not been certified in accordance with 104.2.2C(4).

**RULES:** The 2011 USA Rules will govern the conduct of the meet unless noted otherwise herein.

**ELIGIBILITY:** All participants must be USA Swimming registered athletes. Entries will not be accepted without 2012 registration numbers. Coaches and officials must present evidence of certification as required by Southeastern Swimming. A swimmer's age on the first day of the meet will determine his or her age for the entire meet.

OPEN events are available for entry to all age group swimmers ages eleven and OVER who are eligible to swim the stroke and distance at a short course meet.

**WARM-UP:** Southeastern Swimming Meet Safety Guidelines and Warm-up Procedures will be in effect at this meet. Warm-up assignments will be posted on the HSA website, posted around the pool deck, and copies will be included in coaches' packets that can be picked up at Clerk of Course before the start of the first session.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Swimmers attending the meet without a coach must report to the Meet Director to be assigned a coach for warm-up prior to each session.

*Friday PM session will consist of all eligible age groups.  
Saturday & Sunday AM sessions will consist of all 10 & Under girls and boys.  
Saturday & Sunday PM sessions will consist of all 11 & Over girls and boys.*

**ENTRY FEES:** \$5.00 per Individual event. \$10.00 per Relay event. \$5.00 facility surcharge per athlete. NOTE: Southeastern Swimming Inc. requires a surcharge of \$3.00 per swimmer for in-LSC swimmers, and a \$5.00 per swimmer for non-LSC swimmers, which is used for administration and travel fund of Southeastern Swimming, Inc.

Late entries will be accepted at the discretion of the meet directors. Late entries will be charged \$6.00 per Individual event and \$12.00 per Relay event.

All entry fees are non-refundable.**

**ENTRIES:** See attached list of events. **All events are Short Course Yard and Timed Finals.**

Swimmers are limited to five (5) individual events per day, exclusive of relays.

Only ages 11 & Over will be allowed to swim OPEN events.

HSA strongly requests that ALL ENTRIES be submitted via HYTEK's Team Manager. Teams without "Team Manager" must submit the enclosed entry forms completely. Entries must be completely filled out including the swimmer's best times for yards.

All teams are asked to completely fill out the enclosed **Team Information Form**, including the names and contact numbers for all registered officials affiliated with the team that are willing to serve as a meet official during the weekend.

***Entry error:*** *If due to an HSA error, the swimmer will be deck entered in an open lane of the heat nearest his/her entry time or in a new heat. The entire event will not be re-seeded.*

**DISABILITIES:** Swimmers with disabilities are welcome. Please complete the "information Form for Disabled Swimmers" and return it with the entries.

**SEEDING /**

**MEET FORMAT:** See attached list of events. This is a timed finals meet, and will be pre-seeded except for the following events: the 400 IM, all 500 Freestyle events, the 1000 Freestyle, and the 1650 Freestyle, which will be deck seeded and swum fastest to slowest alternating girls' and boys' heats. OPEN results will be posted separately by age group. HSA reserves the right to limit the number of heats in deck-seeded events in order to run the meet in the allotted time.

Swimmers must check in for the deck-seeded events by the conclusion of the warm-up session for the event. Only the swimmer or his/her coach may sign in for deck-seeded events.

**Failure to swim a deck seeded event after signing-in may result in the swimmer being barred from swimming his/her next individual event.**

- DEADLINE:** Entries, waivers, and entry fees, including all meet fees and surcharges, must be received by the Entries Chairman by midnight **Tuesday, January 24, 2012. No late entries will be seeded.** Only the first 250 swimmers per session will be accepted. Late entries may be accepted at the discretion of the Meet Director; however, they will be accepted on a "lane available" basis and may not appear on the heat sheet.
- AWARDS:** Ribbons will be awarded for first through eighth place in all 12 & Under individual events, and first through third place in relay events. Heat winner ribbons will be given for 12 & Under Individual events.
- Results for event # 3 & 4 (200 IM), event # 1 & 2 (400 IM), event #7, 8 (500 Free), event # 111 & 112 (1000 Free), and event # 9 & 10 (1650 Free), will be posted by age-group and awarded appropriately for 12 & Under age groups.
- SCORING:** Points for first through eight places in individual events will be awarded as follows: 9-7-6-5-4-3-2-1. Points for first through eight places in relay events will be awarded as 18-14-12-10-8-6-4-2.
- MEETINGS:** A coaches' meeting will be held at the discretion of the Meet Referee. No swimmers will be allowed in the pool during the coaches' meeting. Officials' Meeting will be conducted approximately 30 minutes before the start of each session. Timers' Meeting will be conducted approximately 10 minutes before the start of each session.
- ADDITIONAL NOTES:** **Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.**
- All-American Swim Supply will be on-deck Saturday and Sunday**
- There will be a Bull Pen for 8 & Unders.**
- Results Files will be available at the end of the meet and on our website at [www.swimhsa.org](http://www.swimhsa.org).**
- Once entries are received and an estimated timeline is produced, estimated warm-up times will be posted on [www.swimhsa.org](http://www.swimhsa.org).**
- There will be a break between the 100 Fly and 500 Freestyle events on Saturday.**
- Each swimmer is required to provide their own lane counter for the 500 Freestyle events (Event # 7, 8, 61 & 62).**
- Each swimmer is required to provide their own lane counter and timer for the 1000 & 1650 Freestyle events (Event # 9, 10, 111 & 112).**
- The meet director reserves the right to run this meet in an 8, 10, 16, or 18 lane format (16 or 18 lane formats will be in two courses) depending on the number of entries received.**
